Please refer to **page 73 of the EA Dressage Rule book** for full conditions and requirements to take part in the Challenge. Below is an extract of some of the conditions.

8.12 Conditions for Nomination

- the competition is open to nominated combinations with horses of any origin with the following restrictions
- horses may enter qualifying events once they have turned **7 years of age** (1 August for Southern Hemisphere Horses, 1 January for Northern Hemisphere Horses)
- horses must be **11 years or under during the calendar year of the competition**
- horses must be registered with the EA
- riders and owners must be financial members of EA
- each combination seeking selection must compete in at least two qualifying competitions (in their own and/or another State). **This may include a State Final.**
- riders may compete in State Qualifiers and Finals other than in their own State provided they have obtained written permission from the ADC

Any change of rider must be notified in writing to your SDA as soon as it occurs. Your SDA will advise the EA National Office of the change. Note that should a rider be changed, the horse and rider combination must compete in at least 2 qualifiers as per the above rules.

8.13 Qualifying Events and State Finals

- each State will hold up to five qualifying competitions and a State Final
- at least two qualifying events in each state should be held on or after 1 August to enable those horses turning 7 an opportunity to qualify. This may include the State Final
